**This informational video** about the risks facing montane longleaf forests was put together by the Guild and partners at the University of Alabama, Berry College, and Georgia Department of Natural Resources.

Did you know that the Forest Stewards Guild partners with agencies to offer internships for students and early-career professionals? We're at it again in 2021. Forest Certification Update 2021: The Pace of Change.

Lower cost and more feasible options to restore forest cover in the contiguous US for climate mitigation. Authors say, "We found up to 51.6 Mha of area in the US to restore forest cover, which is about double the size of Oregon. These new forests could capture 314 MtCO2 year-1, equivalent to the annual emissions from 67 million cars."

Challenges to the Reforestation Pipeline in the United States. Large-scale global reforestation goals have been proposed to help mitigate climate change and provide other ecosystem services. Additional investment (not included in the reforestation cost estimate) will be needed to expand capacity for seed collection, seedling production, workforce development, and improvements in preand post-planting practices.
