#### A note from the Director


Dear Forest Stewards Guild Members and Friends,

#### **Publications and Research**

Fire effects on the persistence of soil organic matter and long-term carbon storage suggests that in temperate forests, savannahs, & grasslands fire can stabilize or even increase soil carbon. "We hope this new study will show that when managed properly, fire can also be good -- both for maintaining biodiversity and for carbon storage."

Want to limit carbon and curb wildfire? Create a market for small trees. This new analysis provides a roadmap for how to effectively reduce wildfire risk through forest thinning while continuing to limit its carbon emissions by creating a market for small diameter trees and other woody biomass.

Forest restoration limits megafires and supports species conservation under climate change. "Even under climate change, forest management can move the needle on forest ecosystem conservation by reducing future stand-replacing fire and do so in a way that safeguards habitat for sensitive species like the California spotted owl."
